2. Big Island Lake Weed Control Update: Currently they do not have the petitions to submit and proceed with creating a Special Assessment District for the weed control. Discussion proceeded about the distance they are allowed to spray from the shoreline into the lake and it was confirmed that there was a setback, but the exact amount was unknown to the Board at this time. Additional discussion affirming that the petition signatures had to be from Wilber Township residents and any signatures from Plainfield Township would have to be presented to the other Township. We are only setting up the Special Assessment District for Wilber Township.

Further discussion from the guests that many residents may have been misinformed as to what they were signing up for when they signed the petitions. We clarified that what we had agreed to have Savin treat, was performed and previously discussed, but there are no promises if the treatments would work and that is up to the residents to decide if it was working and how they would want to proceed. Guests and the Board discussed the change of traffic from propellers to jet skis and the impact that is having. It was further discussed that they would not have petitions in time for a Special Assessment to make the 2025 winter tax bill. One guest noted they are in the process of creating a Lake Association.

Discussion then moved from the weed control to the boat launch. Confirmation was made that there is public access to the lake, but people may not be happy with it because it may go directly into the muck, but it is a public access.

- **3. ADA Compliance Grant** Clerk Pingot discussed that a few contractors had come to look at the request for the work and we had not yet received any bids.
- **4. Consumers Energy Ordinance 2025-002** Provided to all guests and the Board. We have previously discussed and agreed to have our Lawyer review.
